Baker Fanny	29-02-1828	BB	Was delivered of a female bastard child at HORSINGTON, Father William Elvin of TETFORD Schoolmaster. Ordered t pay £1 10s to parish for birth expenses and 2s 6d per week upkeep. Fanny Baker to pay 6d in case she shall not nurse and take care of said child.
Bannister Edward	12-06-1817	SE	(born EDLINGTON 1793) Stated previous to Mayday 1813 hired by John Grayson of REEVESBY. In 1814 hired by John Birkinshaw of HORSINGTON as a "Confirmed Labourer for a year and that the agreement between him and his master was that he should have a house and garden, the sum of a cow and two pigs on his masters farm at HORSINGTON aforesaid and £20 as his wages and that he now lives with said John Birkinshaw
Bell Richard	19-06-1813	SC	(born STURTON Notts 1790) Previous to May Day 1809 hired by William Harrison of BULLINGTON for 1 year

Becton James	29-03-1805	SE	Saith he is 29yrs of age born in the parish of HATTON. Heard and believed tht his last legal place of settlement is at HORSINGTON having, when 22 years of age or thereabout been hired by Joseph Turner of Horsington aforesaid farmer, as his servant for 1 year from Old Mayday to Old Mayday the following year at the wages of 13 guineas
Blackburn William	09-09-1826	SE	(born BARDNEY 1797) Legal settlement of his parents is the parish of MINTING, 1817 hired by Mr Robert Thorpe of BUCKNALL (Farmer) he then worked as a labourer in different places for the space of 2 years when he married.
Blades Joseph	18-08-1826	SE	(Born 1801 in HORSINGTON) He has lived in various places as a servant in husbandry and that in the year 1821 he was hired by Francis Richardson of EDLINGTON farmer
Blakewell Robert	27-06-1807	SE	In the year 1798 he was hired by Benjamin Silverwood of SNELLAND for 1 year
Boades William	04-09-1805	SC	From CW AN Overseer of the Poor HALTHAM acknowledging WB wife and Family to be legally settled in HALTHAM
Boll John	05-07-1795	SC	From CW and Overseer of the Poor of RADBOURN acknowledging JB Mary his wife and John & Elizabeth their children to be legally inhabitants of RADBOURN
Bonner Robert	06-12-1757	SC	FromCW & Overseers of Poor of Parish of NORTH KYME acknowledging RB and Alice his wife to be legally settled in the parish of NORTH KYME
Borrill Jane	23-12-1826	RO	Jane wife of William Borrill of CONINGSBY and Rebecca their daughter ordered to return to CONINGSBY

Borrill John	24-12-1841	SE	<p>(born CONINGSBY 1799) Parents legally settled in parish of Horsington. I have not been out in service as to gain settlement as I believe I was bad of sight and was put out amongst the farmers there. I was 3 years and a half with Mr Smalley. I did not let myself. There was a meeting called and I was let at the meeting and many poor boys beside me. I had no wages and my master gave me what he pleased and the parish fined him for taking me, Mr Birkinshaw of HORSINGTON aforesaid then took me in the same way. I went a little bit after Mayday and stopped 'till the May Day following. I then went to work for Mr Thomas Dickinson of TATTERSHALL but did not let myself to him by the year and lodged with my Father-in-law at TATTERSHALL THORPE. I was married at TATTERSHALL church to my present wife Martha and have 2 children living. Benjamin 11 yrs and Charles 6 yrs. Since I married I have never paid more than £6 a year for my house. I have never rented a tenement of £10 a year nor done any other act whereby to gain settlement in my own right. I believe my father gained his settlement at HORSINGTON by hiring and service. He died when I was very young leaving a widow and 3 children. The parish of HORSINGTON maintained us until we could earn out our own living. My mother married again and got to belong to another parish. I have a brother William Borrill now living in HORSINGTON. He became chargeable to the parish and they have done a deal for him as he has a large family. I am now together with my wife and children chargeable to the hamlet of TATTERSHALL THORPE.</p>

Barratt John re Borrell John	18-01-1842	SE	<p>I am about 66 years of age and 32 years ago (1810) on 11th December I was married at CONINGSBY to Elizabeth Borrill widow of John Borrill of CONINGSBY labourer whose settlement I believe was at that time in the Parish of HORSINGTON. At the time I married she had 3 children John, William and Rebecca Borrell living with her at CONINGSBY and they were at that time receiving relief from the overseers of HORSINGTON being 2/- a head.</p> <p>After I married her I received 6/- a week of the overseers of HORSINGTON being 2/- each for the maintenance of each of Borrill's children This sum I received off Mr Smalley from December when I married her to Lady Day following being then with my wife and her 3 children resident in the parish of CONINGSBY. I then removed into the Fen and lived 2 years with my wife and her 3 children in the parish of BOLINGBROKE and I received 6/- a week off the Overseers of HORSINGTON for the, maintenance of Borrill's children the whole of that time, I used to go over to HORSINGTON once a quarter and received the money off the overseers Mr Hannah and Mr Addison. After leaving the Fen I went to live at TATTERSHALL THORPE and whilst living there I also received relief for the 3 children from the Overseers of HORSINGTON for 2 years. The last money received was half a guinea off Mr Burkinshaw for the pauper John Borrill for keeping him the last winter. After that he did for himself.</p>

Bowering Ann	05-07-1834	RO	To BUCKNALL being now with child or children which child or children are likely to be born a bastard or bastards and the said Ann Bowering being poor.

Bowering Edward	18-12-1830	SE	(born HORSINGTON 1805) born at HORSINGTON where my parents are legally settled as I have been informed and believe. I have lived in several places as a servant in husbandry and about a fortnight before Mayday in the year 1821 I let myself to William Smalley of Horsington (Farmer) to be his servant in husbandry for 1 year with whom I lived the whole of that year and received my full years wages. I do not remember that I had any holiday for that year. Since that time I have not served a whole year in any one place nor have done any other act etc,
Bowering Edward	05-01-1833	RO	Order made for removal from BARDNEY to HORSINGTON for EB his wife Mary Frances 2 yrs and Rose Ann 9 weeks.
Bowering Mary	15-03-1850	SE	Containing Examination of her father Cornelius Bowering as to her legal place of settlement. Naming the Hamlet of NEWBALL (Mothers name Elizabeth m Nov 1814) Mary Bowering is said to be receiving relief from the parish of HORSINGTON for a sickness that is such as will produce permanent disability. Order is made for removal to NEWBALL. Bill dated 25-03-1850 from Richard Clitherow Clerk to the justice for the examination of Cornelius Bowering and removal notice etc £2-10s-6d. BURIEL REGISTER entry No 193 11-08-1858 Mary Bowering Horsington aged 29.
Bradshaw Edward	13-10-1785	SC	From chwdn. and Overseer of parish of HEMINGBY acknowledging EB his wife and Family to be legally settled in the parish of HEMINGBY

Bradshaw John	10-03-1832	SE	<p>(born Nettleton 1790) When I was about 12 years I was bound apprentice to Robert Brant of ROTHWELL for 7 years. Served 2 years when my master failed and my indenture were transferred for the remainder of the term to John Rowbuck of GREAT LIMBER and served him for 5 years when I went away from my master to work as a Journeyman Blacksmith at KELSTERN for 4 months. Worked in LONDON, CANTERBURY and several other places in different Counties as a journeyman but never let myself by the year.</p> <p>About 5 years ago I came to live at BOSTON, hired a house, Blacksmith shop and premises in PENN STREET off Mr Cartwright the ships chandler at the yearly rent of £15. Occupied for 1 1/2 years. I then removed to LEAKE where I hired a house from Lady Day 1830 to Lady Day 1831 off Mr William Barton of LEVERTON (farmer) at the rent of £5-5s per annum and also a shop from John Allgirth of LEAKE (Farmer) at the yearly rent of £5. I occupied both house and shop for nearly 2 years. I left that parish about 9 weeks ago and came to reside at HORSINGTON.</p>
Brader Samuel	07-02-1834	SE	<p>In 1834 hired by Richard Wilson for 1 year at £9 per year + 2 ½ crown fastening Penny and 3 days holidays. Started on the Mayday because MR Wilson wanted him to” fetch the girl from Stixwould Ferry.”</p> <p>Appeal against removal of SB his wife Elizabeth and 2 children George 4 yrs and Robert 2 yrs. from SCAMBLESBY to HORSINGTON</p>
Brice Robert	20-10-1769	SC	<p>From CWdn and overseer of the parish of SCAMBLESBY acknowledging RB and Ann his wife to be legally settled in the parish of SCAMBLESBY.</p>
Brooks Robert	06-03-1806	SE	<p>(Born SIBSEY 1791) 27-9-1806 he was bound apprentice by indenture to Brocket Wilson of BUCKNALL Cordwiner for the term of 7 years. At the expiration of 5 years and 3 quarters he absconded and during his absence his father under an agreement with his master the said Brocket Wilson that he should pay him the sum of nine guineas for his son to be released.</p>
Bucknall Joseph	11-06-1825	SP	<p>(born HUTTOFT 1778) Stated that in 1800 he was hired by Mr Joseph Rogerson of WADDINGWORTH</p>

Burnitt Thomas	12-06-1819	SP	(Born HORSINGTON) Father died when he was not more than 2 years old and that when he was about the age of 12 years his mother intermarried with John Thistlewood of TUPHOLME where he the examinant went to reside That he continued to live with Mr Thistlewood until his death and afterwards with his mother until about a year and a half ago.
Butters Robert	25-12-1752	SC	From chwdn. and Overseer of parish of HEMINGBY acknowledging EB his wife and Family to be legally settled in the parish of HEMINGBY
Cade Barnard	14-06-1825	SE	(Born BUCKNALL 1821) 5yrs since 1st Mayday he was hired by MR John Parkinson of ASWARDDBY for 1 year
Cammack James	28-12-1822	SE	(born CONINGSBY 1799) Previous to Mayday 1818 hired by Charles Fanthorpe of TUMBY WOODSIDE for 1 ½ years
Carter Rodger	15-05-1729	SC	Chwdn. and Overseer of parish of From KIRKBY SUPER BAIN Acknowledge CR & his Wife to be legal inhabitants of the parish of KIRKBY SUPER BAIN.
Cash Edmund	18-11-1815	SE	(born STIXWOULD 1780)
Chapman John	21=03-1806	SE	6 years since old Mayday let himself for 1 year to Moses Fox of SOUTHREY
Clayton George	25-10-1806	SE	Old Mayday 1802 hired for 1 year to Robert Findar? of WOODHALL. Served 3 years. 1805 hired for 1 year to John Cooke of WALCOT served him there under such hiring until 30th April next following and received his wages only up until that time when he parted his masters service by consent and then went to WOODHALL and married there where he continued about 1 week and then went to reside at the parish of HORSINGTON.
Clipson Dinah	28-12-1805	SC	From Chwdn. And Overseer of the parish of BAUMBER acknowledging her to be an inhabitant legally settled in our said parish of BAUMBER
Clipson Elizabeth	26-12-1835	BB,	Bill from M/s Clitherow and son referring to Benjamin Beavin of BARDNEY being father of Elizabeth Clipsons Bastard Child.

Clipson Jane	18-07-1829	SE	(Born HORSINGTON 1807) she has lived in several places as a servant and that at Michalmas 1826 she was hired to William Higgins of REEVESBY BANK (farmer) until Mayday 1827 when she went away, and her clothes were sent by her master to HORNCastle. Examinant went the next day to HORNCastle PACK RAG DAY and was again hired by her master until the next Mayday and that her master gave her 4 days holiday and that she entered upon his service and remained until about 3 weeks before Mayday 1828 when her Master and she disagreed and both being willing dissolved the contract and she left.
Clipson Sophia	03-11-1832	SE	(born HORSINGTON 1815) Lived at home with my mother until 15 years old and then went into service. My mother let me the day after Mayday 1830 to Abraham Hanson of HORNCastle let again the following year. I was so ill at the time of the feast with a sore throat that I could not get to the feast and I had my holidays after Christmas instead and was 10 days at home. I have been so ill this last year that I have been incapable of Service.
Clipson John	31-05-1834	SE	(born KINGERBY 1796) Settlement of my parents was in the parish of HORSINGTON. When I was 12 years of age, I went into farmer's service. I went in the month of January of February to live with John Eastwood of HORSINGTON (farmer). I served him in that parish the whole of that year and the 2 following years under yearly hirings. I then worked as a labourer for a year and a half the enlisted into the army for 21 years 3 months. I married when in the Army and have not done any act since I left HORSINGTON whereby to gain a settlement.

Coleby Dixon	17-12-1832	SE	<p>(born LONG BENNINGTON 1802) Parents belonged to ANCASTER where I lived until 12 years old. I then went into farmers service and served my first whole year with W Fow in SUDBROOK in parish of ANCASTER. I gained many settlements in different places as a farmer's servant and 5 years ago last HORNCastle OCTOBER FAIR I let myself to Mr Richardson of STIXWOULD from that time to the next Mayday and on the HORNCastle STATUTE Day morning previous to Mayday I agreed another year with Mr Richardson at the wages of £14 and 5/- for a fastening penny. Nothing was said about Holidays when we bargained, and I received the 5/- when Mayday came. I asked my Master for 3 days holiday and he said I might. I served the whole year and was hired for another year and served until about a week after the next midsummer.</p>
Collings Abraham	18-04-1718	IND	<p>Putting AC a poor child of the parish Apprentice to John Longstaff of HORSINGTON (Yeoman)</p>
Coo Rachael	02-10-1835	SE	<p>(born HORSINGTON) Spinster residing at THORPE ON THE HILL with Henry Causebrook of that Parish Farmer. That she has been in his service nearly 2 years. She was first hired by him 11 weeks before Mayday 1834 thill the Mayday and then hired again for a year until this last Mayday but bargained at the time of hiring that she should have a weeks holiday within the year and that for nearly 3 years before she entered onto the service of Mr Causebrook she was in the service of William Wheatcroft of that parish that for a year previous to her 1st service with Mr Wheatcroft she was in service with Mr Benjamin of HAGWORTHINGHAM but under a hiring a week after Mayday that year previous to her service a HAGWORTHINGHAM she lived with Daniel Jeggs of HORNCastle under a hiring a fortnight before Mayday but with stipulation that she was to have a wees holiday at the Feast.</p> <p>RO dated 02-10-1835 for removal of Rachael Coo from THORPE ON THE HILL</p>

Coo William	28-04-1804	SE	(Carpenter) 8 years since next Old Mayday he was bound apprentice by Indenture to John Barnaby of HOLTON CUM BECKERING for a term of 6 years.
Cooke Joshua	15-01-1821	SE	(Born Timberland 1799) Parents settlement in parish of DUNSTAN. In year 1824 and about a week before the Mayday. I let myself to John Elmitt of HORSINGTON (Farmer) for a year namely from the then Mayday to Mayday 1825 at the wages of £6 6/- after I had bargained for the wages and received my fastening penny my master asked me when I should come. I fixed about 1 week and went into his service at that time. I served the whole of that year and previous to the next Mayday he hired me again. (1825 – 26)
Cordy Richard	28-12-1822	SE	(Born BARDNEY 1800) Mayday1813 he was bound apprentice by indenture to John Brown of WALCOTT (Wheelwright) for 7 years and served his full term.
Cordwainer George	07-11-1785	SC	From Chwdn. & Overseer of the poor of parish of BARDNEY. Acknowledging GC and his wife to be legally settled in BARDNEY for GC and Wife
Croft Harry	19-06-1813	SE	(Born MAREHAM LE FEN 1790) Previous to Mayday 1809 he was hired by William Carter of BUCKNALL for 1 ½ years
Croft William	31-03-1806	SE	5 years past at Mayday he let himself to Joseph Rogerson of WADDINGWORTH. Served 2 years

Cummings George	21-11-1811	SE	<p>(born ASHBY BY SPILSBY 1779) Previous to May 1806 hired by George Whitcham of Sows in the Parish of LUDFORD as a servant in Hand for 1 year. i.e. Mayday 1806 to Mayday 1807 served full term and received full wages. That at Ladyday 1809 to a cottage at SIBSEY for 1 year at the rent of £4 4/- that at old Michalmas in the said year in addition to the said rental he took a cottage and about 2 1/2 acres in HORSINGTON off Mr Emmett of SAUSTHORPE at the yearly rent of £7 that he entered upon said cottage and land at Old Michalmas aforesaid to reside on the same and that he has since continued to reside there and that he also continued the occupation of the said cottage at SIBSEY 'til Ladyday 1810 making a clear yearly rental of £11 4/- for the last year.</p> <p>In pencil on the bottom:-</p> <p>1813 at Lady day he let himself as a confined Labourer for 1 year to Charles White of HORNCastle. To live in the HORNCastle ALLOTMENT in WILDMOOR FEN. Wages House and Garden the milk of a cow where he lived for 4 years. (1821-22 received poor rate relief of £1 13/-</p>
Cummings George	29-12-1811	RO	<p>Notice of appeal to against the removal of GC Elizabeth his wife William 13, Thomas 11, Elizabeth 9, Henry 7, Sarah 4. From LUDFORD MAGNA to HORSINGTON</p>
Cummings Elizabeth	24-01-1835	SE	<p>(Wife of George Cummings) 2 years ago last Lady Day my husband went to live as a confined labourer wit Mr Charles White of HORNCastle (Farmer) He was to live on Mr White's farm in the WILDMOOR FEN PAROCHIAL ALLOTMENT as his groundkeeper. He had a house and a small Garden rent Free £26 a year wages the milk of 1 cow, the rum of 2 pigs and half the profit of 2 geese, a dozen hens and 4 ducks which were kept and fed upon Mr White Farm. My husband served Mr White 4 whole years and lived in the same house in Horncastle Fen Allotments and enjoyed the same privileges each year. My Husband never had the profit of more than one cow during the 4 years.</p>

Dannath Philip	10-11-1776	RO	PD a male Bastard Child had lately come to inhabit the parish of MIDDLE RASEN. On Examination his mother now Mary Mountsfield saith that the child is chargeable to the parish of HORSINGTON
Darwin William	06-04-1733	SC	From Chwdn. & Overseer of the poor of parish of EDLINGTON. Acknowledging WD as an inhabitant of EDLINGTON
Daubney Robert	10-05-1725	SC	From Chwdn. & Overseer of the poor of parish of NETTLEHAM Acknowledging RD his wife and family to be legally settled in Nettleham
Dawson George	10-04-1817	SE	(born BUCKNALL 1774) Lived at home with his father until he was 28yers of age when his father died. That after his father died he and his brother occupied a farm jointly in BUCKNALL for 7 years at a rent of £90 and upwards. That at Ladyday 1813 he entered upon a farm at BRANSTON at the annual rent of £95 or thereabouts and occupied the same until Ladyday following during which time he resided in BRANSTON 10-04-1817 RO for GD His wife Rebecca Thomas 9 and Arthur 6 to BRANSTON
Dawson William	13-10-1830	SE	(born THORNTON 1795) Lived with parents until about 13 years old and let myself as a servant in husbandry. I was about 6 or 7 years in service in different places. About 16 years singe Pack Rag Day at HORNCastle Road Statute I let myself to Thomas Porter of BUCKNALL (Farmer) as a servant for 1 year and lived with him 2 years under yearly hirings. I did not bargain for any holidays in either of the years and I left Mr Porter about a fortnight before the Mayday in the last year.

Day Mary	27-12-1828	BB	<p>Order re female Bastard child born 08-11-1827 at HORSINGTON. Joseph Holmes (Schoolmaster) of BELCHFORD father of the child. Father to pay £5 for expenses incurred at birth of child and 2/6d weekly. Mother to pay 6d weekly.</p> <p>15-12-1832 Doc naming Joseph Holmes (Schoolmster) of BELCHFORD to be father of female bastard child born of Mary Day Single woman in the said Parish of HORSINGTON. This doc states that Joseph Holmes neglected to pay the sum of 2/6d weekly and therefor the sum of £3 10/- is owing to the parish of HORSINGTON Order that Joseph Holmes must appear before the Magistrate at HORNCastle on 29-12-1832</p>
Dean Arthur	18-04-1778	SC	From Chwdn. & Overseer of the poor of parish of HOLTHAM UPON BAIN. Acknowledging AD and his wife and family to be legally settled in HALTHAM UPON BAIN.
Drew Thomas	14-07-1735	SC	From Chwdn. & Overseer of the poor of parish of MINTING. Acknowledging TD and Marg his wife to be legally settled in MINTING
Dennis James	14-06-1817	SE	(born KIRKSTEAD 1787) July 1815 he rented house and garden and about 2 roods of potato land at WOODHALL for a yearly sum of £6 and occupied the same one whole year and that whilst in the occupation of said house and garden and potato land he had the agistment of a cow given to him by Richard Elmhurst of WADDINGTON for whom he sometimes worked and in lieu of wages for looking after his masters cattle.
Drayton Elizabeth	10-11-1827	RO	Removed to HAMMERINGHAM
Duckering John	11-07-1807	SE	He let himself as a yearly servant to George Bramley of WISPINGTON (Farmer) at Mayday 1801 and that he lived 2 years with the said George Bramley . In 1803 he let himself as a hired servant to William Bonner of WISPINGTON for 1 year
Eastgate Richard	27-04-1754	SC	From Chwdn. & Overseer of the poor of parish of LOW TOYNTON. Acknowledging RE and his wife and family to be legally settled in LOW TOYNTON

Eastwood John	01-03-1834	SE	(Born HORSINGTON 1786) About the month of March 1831 I hired 3 acres of land siting in the parish of SCAMBLESBY of Thomas Brader , He was to build me a house on the land at the rent of £11 10/- per annum from Mayday -Mayday. I entered onto the land a short time before Mayday 1831 and at that the house being finished. I entered into it. I paid the rent for the year before that Mayday as Brader wanted money to build the house with. I occupied the house and land that year and the following 1832-1833 and paid half the second year's rent at Louth Michalmas Fair and the remainder was paid on 10 th May 1833 by William Elsey an my account. I paid him the same again when I sold my cows. I was the tenant myself the whole time my father did not hire the premises nor was he answerable for the rents. I received a notice to quit at Martinmas 1832 and left the premises at the Mayday 1833.

Elvin William	06-03-1819	SE RO	Previous to Mayday 1815 hired by Edward Wells of MAREHAM ON THE HILL. Same day RO for WE his wife Ann and Benjamin 2years to go back to MAREHAM ON THE HILL
Elvington John	06-02-1741	SC	From Chwdn. & Overseer of the poor of parish of LUDBOROUGH. Acknowledging AD and his wife and Mary 2yrs, and Richard 1 yr to be legally settled in parish of LUDBOROUGH
Everton James	19-12-1829	SE	(born EAST KEAL 1809) Parents legally settled in TUPHOLME lived in several places in the year 1826 about a fortnight before Mayday I was hired by Joseph Mowbray of BARDNEY in the said parts labourer to be his servant for a year. Lived 1 year with him
Evison George	06-03-1819	SE	(born Conningsby 1799) 1815 hired by Mr Waterman of WESTVILLE

Evison Mark	31-03-1749	SC	From Chwdn. & Overseer of the poor of parish of KIRKBY SUPER BAIN. Acknowledging ME labourer and his wife Rebecka to be legally settled in KIRKBY SUPER BAIN
Farrow Thomas	12-06-1819	SE	(Also known as Thomas the younger) Butcher (born HORSINGTON 1791). Sometime in the month of May 1805 apprenticed to Henry Harrison of BARDNEY (Butcher) for the term of 5 years. 4 ½ years of which term he served and then parted by mutual consent.

Fenwick George	06-08-1836	SE	<p>(born GREAT STURTON 1811) My father is a carpenter and I remained with him and learned the business until I was 16 yrs of age. I served my master the whole of that year in WOODHALL except the last 9weeks when I ran away and worked for another Master but I returned at the end of 9 weeks and served Mr Dennis for 9 weeks and 2 days to make up my years' service and my master paid me the whole years wages. I then married and have been generally working as a journeyman for Mr Dennis ever since.</p> <p>I have never rented a tenement of £10 a year or done..... I am now together with my wife Sarah and 2 children Elizabeth 2yrs and William 10weeks actually chargeable to the parish of HORSINGTON.</p>

Visey William	24-12-1811	SE	(born GRASBY 1781) At KEALBY STATUTES about a fortnight vbefore Mayday hired by George Nelson Esq of GREAT LIMBER.
Wakefield Elizabeth	14-11-1762	BB	Order made by Edward Munk of FRAMPTON to pay £50 to the Churchwarden and Overseer of the POOR of HORSINGTON for the care and upkeep of the unborn Child.
Wallis Alice	08-01-1825	BB	Male Bastard Child born in HORSINGTON Father named as Charles Scuffam Farmers Servant in HORSINGTON. Charles Scuffam then absconded and there are several entries in the overseers book re tracing CS to MAREHAM LE FEN, and BRIGG, arresting him etc. and expenses accrued.

Watson John	21-02-1811	SE	(born KIRKBY UPON BAIN 1764) 24 years ago took a cottage and about 2 ½ acres of land at SKIRBECK at the yearly rent of £10 5/- and resided upon the same for about 14 years at that rent. Mr Barnard of BOSTON having purchased the cottage and land, raised the rent for the same to £11 11/- and that he occupied the same for about 7 years up to Ladyday 1808. About Candlemas 1808 he went to reside at STIXWOULD with his sister Prudence Kent .

Wiles Sarah	16-02-1828	RO	For SW, wife of Robert Wiles of BILLINGHAY, and Anne aged 4 years and Maria aged 2 years to be returned to BILLINGHAY
Wilson Matthew	22-04-1753	SC	From Chwdn. & Overseer of the poor of parish of STAINFIELD. Acknowledging MW his wife and Family to be legally settled in STAINFIELD.
Wise Joseph	10-04-1753	SE	(born BOLINBROOK 1753) stated he was born at BOLINGBROOK where he continued until he was about 10 years of age when he was bound a parish apprentice to John Tinker of the said parish of BOLINBROOK that he continued with his said master until he was about 20 years of age when his master died and his mistress set him at liberty and gave him his indentures and that he has not since been a yearly hired servant rented £10 a year , served or done anything to gain legal settlement , that he has a wife living at HORSINGTON Elizabeth to whom he was married about 3 years ago and an infant child called Daniel.
Wright John	19-06-1813	SE	(born BOOTBY GRAFFO 1784) States sometime previous to Mayday 1808 hired by Philip Bullen of GREETWELL (Farmer) Served for 2 years. Slept in parish of BRANSTON except for 3 weeks at Harvest each year when he slept at GREETWELL

Wright John	18-02-1821	SE	(born HORSINGTON 1799) Mayday 1818 hired by MR James Donwhater of SOMERSBY worked for 2 years. Doc Dated 18-02-1826 requesting return of John Wright to SOMERBY
Wrighton Samual	01-12-1821	SE	(born DUNSTON 1799) 1st day of March 1813 he was bound apprentice to William Smith of BARDNEY 9 Cordwainer) for 5 years and that he lived the whole of the said term with Mr Smith in BARDNEY aforesaid.
Wrighton Samual	01-10-1836	RO	For SW Jane his wife, Francis 8 years, Elizabeth 6 years, William 5 years, James 3 years, and John 3 weeks to BARDNEY
Yarnall Thomas	11-07-1807	SE	Let himself as a yearly servant to William Kirkby of WISPINGTON from Mayday 1803 tp Mayday 1804 and that he lived 3 years with the said William Kirkby and received his full wages i.e 1803-1806.
